

To qualify for a rebate:

- This offer applies only to irrigation meter customers who have an active water account in good standing within the City of Pleasanton, and are participating in Zone 7's or City of Pleasanton's Water-Efficient Landscape Program.
- Site must currently have a weather-based irrigation controller, or be applying for a weather-based irrigation controller through Zone 7 in conjunction with this application.
- Site must have a water use history (minimum of past 3 years).
- Site must have a well-maintained irrigation system that is in good working order.
- Applicant must install specified hardware per manufacturer's directions.
- Installation must be complete before issue of rebate
- Rebate application must be postmarked within 60 days of purchase date.
- Sales tax, installation, programming costs, and any other fees are not rebated.
- Rebated items must remain on-site for a minimum of two-years.
- Approved irrigation hardware must be free of leaks and malfunctions, and must not create run-off, overspray, or misting.

Funding is limited. Rebates are one-time-only per retrofitted area, and will be provided on a first-come, first served basis.

Applications and receipts must be postmarked, emailed, or faxed within 60 days of purchase. You have two options for submitting your rebate application:

1. Complete the City of Pleasanton WEI rebate application available at www.pleasantonwaterconservation.com. Scan your original sales receipt and water account bill and save as PDF files. Email a copy of application and the scanned sales receipt(s) to: rdicandia@ci.ca.pleasanton.us Subject: WEI Rebate Application.
2. Mail the application and copy of the dated sales receipt(s) listing the price of the hardware devices seeking rebate to: Water Conservation Division, P.O. Box 520, Pleasanton, CA 94566.

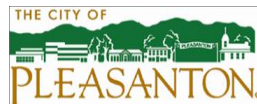
Your rebate will either be issued as a credit on your irrigation account water bill or as a rebate check. Please allow up to 10 weeks to process.

By submitting this application, you:

I, the undersigned, understand that this is a limited, first-come/first-served, one-time program, that rebates are given only for projects for which applications are approved in advance of installation, and that City of Pleasanton is entitled to deny any application that does not meet program requirements. I have voluntarily determined to participate in the City of Pleasanton's Water Efficient Irrigation Rebate. I have independently selected materials, supplies and labor for the purpose of performing the installation. I agree that all work performed will comply with applicable state and local laws, ordinances and regulations. I agree that the City of Pleasanton may visit the premises and verify existing conditions and that the work has been performed. By virtue of these inspections, I understand that the City of Pleasanton makes no determination with respect to whether materials and equipment are free of defects, the quality of the workmanship, or the suitability of the premises or the materials or equipment for the installation. I also understand that the installation of irrigation equipment and landscape materials may not result in lower water bills. If this Application is approved by the City of Pleasanton and the work proceeds, I agree to defend, indemnify and hold harmless the City of Pleasanton, its directors, officers, agents and employees against any and all loss, liability, expense, claims, suits and damages, including attorneys' fees, arising out of or resulting from the installation of irrigation equipment and landscape materials. I agree to a pre- and/or post-installation inspection, upon request.
